



The Graduate Safety Practitioner® (GSP®) designation Application Instructions


When you graduate from a Qualified Academic Program (QAP) you are eligible to apply for the Graduate Safety Practitioner® (GSP) designation. You must apply within one year of graduating.

Steps to apply:

1. Have your university send you a copy of your **conferred** academic transcript. It will take about a month for the school to enter your degree into the registrar, so wait a little bit after graduation to ensure your transcript shows degree earned and date conferred. You will be required to upload a copy of your academic transcript during the application process.
2. Once you receive your academic transcripts, create an account on the BCSP website. Go to www.bbsp.org and click on “My Profile” on the upper right-hand side of the page. On the “My Profile” page, click “New Customer? Click here.”

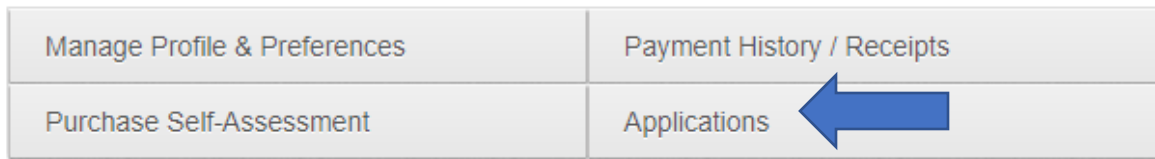

- Once registered your main menu will have a tab “Applications.”



- Choose “Apply for Certification” or if you have already opened the application choose “My Applications”



- Click on “Apply for GSP Certification.”

- Complete the application and submit.
- 5% of all applications are randomly selected for audit. If after submitting your GSP application you receive an audit notification, instruct your university to send your official conferred transcript directly to BCSP. They may be sent electronically; bcsp@bcsp.org or through the mail; BCSP, 8645 Guion Rd, Indianapolis, IN 46268.
- To check on the status of your application, or to complete/submit a previously started application, login to your account and from the menu options, click “Applications” and then “My Applications.”
- Once your GSP application has been submitted and approved, your GSP designation will be awarded. You will receive an email confirmation as well as a mailed packet with a congratulations letter, wall certificate, and instructions on how to maintain your GSP designation.
- You may maintain your GSP designation for up to six years. An annual fee will be assessed each year you hold the designation. Upon having four years of professional level safety experience, you may login to your account and submit a CSP application.
- Once you achieve the CSP, your GSP designation will expire.
